#### 4.1. DESCRIPTION OF FIRST AID MEASURES

#### **INHALATION**

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. If respiratory irritation, dizziness, nausea, or unconsciousness occurs, seek immediate medical assistance. #### 7.1. PRECAUTIONS FOR SAFE HANDLING
