SECTION 4

FIRST AID MEASURES

4.1. DESCRIPTION OF FIRST AID MEASURES

INHALATION

NOTIFICATION PROCEDURES

In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations.

PROTECTIVE MEASURES
