#### **SECTION 4**

#### **FIRST AID MEASURES**

#### 4.1. DESCRIPTION OF FIRST AID MEASURES

#### **INHALATION**

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection.
