SECTION 4

FIRST AID MEASURES

4.1. DESCRIPTION OF FIRST AID MEASURES

INHALATION

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. If respiratory irritation, dizziness, nausea, or unconsciousness occurs, seek immediate medical assistance. 7.1. PRECAUTIONS FOR SAFE HANDLING
