TCP-treated male rats had decreased sperm concentration and motility, abnormal sperm morphology and adverse histologic changes in the testes and epididymides. Adverse histologic changes were also observed in the ovaries of TCP-treated female rats. The percent of sperm-positive females littering was significantly reduced in the TCP-treatment groups with only one of twenty females in the high dose group delivering young. Developmental parameters were unaffected by TCP exposure. Impaired fertility and decreased sperm motility following TCP treatment have also been reported in a reproduction toxicity study in mice.
