SECTION 4

FIRST AID MEASURES

4.1. DESCRIPTION OF FIRST AID MEASURES

INHALATION

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. NOTIFICATION PROCEDURES
