Eve contact

High oral doses in certain strains of rats (F-344) resulted in microscopic inflammatory (microgranuloma) changes in the liver, spleen, and lymph nodes. Some evidence of liver damage was observed. These animals also had some accumulation of saturated mineral hydrocarbons in certain tissues. Similar effects were not observed to the same degree in other rodent strains or in other species.
