## SPILL MANAGEMENT



#### HANDLING AND STORAGE

#### HANDLING

This material is not intended for use in air compressors for breathing applications. Prevent small spills and leakage to avoid slip hazard. Material can accumulate static charges which may cause an electrical spark (ignition source). 
