4.1. DESCRIPTION OF FIRST AID MEASURES

INHALATION

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. In the event of a spill or accidental release, notify relevant authorities in accordance with all applicable regulations.
