Dermal and inhalation studies showed minimal effects; lung non-specific infiltration of immune cells, oil deposition and minimal granuloma formation. Not sensitising in test animals. N-phenyl-1-naphthylamine (PAN): A single oral overexposure may result in clinical signs/symptoms of cyanosis, headache, shallow respiration, dizziness, confusion, low blood pressure, convulsions, coma, or jaundice.
