**4.1. DESCRIPTION OF FIRST AID MEASURES**

**INHALATION**

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. If respiratory irritation, dizziness, nausea, or unconsciousness occurs, seek immediate medical assistance. If breathing has stopped, assist ventilation with a mechanical device or use mouth-to-mouth resuscitation.

**SKIN CONTACT**

Wash contact areas with soap and water. Remove contaminated clothing. Launder contaminated clothing before reuse. If product is injected into or under the skin, or into any part of the body, regardless of the appearance of the wound or its size, the individual should be evaluated immediately by a physician as a surgical emergency. Even though initial symptoms from high pressure injection may be minimal or absent, early surgical treatment within the first few hours may significantly reduce the ultimate extent of injury.

Local necrosis as evidenced by delayed onset of pain and tissue damage a few hours after injection.

emergency use. Chemical goggles are recommended if splashes or contact with eyes is possible. Small spills: normal antistatic work clothes are usually adequate. Large spills: full body suit of chemical resistant, antistatic material is recommended.

## 6.2. ENVIRONMENTAL PRECAUTIONS

Large Spills: Dyke far ahead of liquid spill for later recovery and disposal. Prevent entry into waterways, sewers, basements or confined areas.

## 6.3. METHODS AND MATERIAL FOR CONTAINMENT AND CLEANING UP

**Land Spill:** Stop leak if you can do so without risk. Recover by pumping or with suitable absorbent.

**Water Spill:** Stop leak if you can do so without risk. Confine the spill immediately with booms. Warn other shipping. Remove from the surface by skimming or with suitable absorbents. Seek the advice of a specialist before using dispersants.

## HANDLING AND STORAGE

### 7.1. PRECAUTIONS FOR SAFE HANDLING

Avoid breathing mists or vapour. Avoid contact with skin. Small metal particles from machining may cause abrasion of the skin and may predispose to dermatitis. ## OTHER INFORMATION

### For the product itself:

Repeated and/or prolonged exposure may cause irritation to the skin, eyes, or respiratory tract.
