## **SECTION 4**

## **FIRST AID MEASURES**

## 4.1. DESCRIPTION OF FIRST AID MEASURES

#### **INHALATION**

Remove from further exposure. For those providing assistance, avoid exposure to yourself or others. Use adequate respiratory protection. ## 7.1. PRECAUTIONS FOR SAFE HANDLING

Avoid breathing mists or vapour. Small metal particles from machining may cause abrasion of the skin and may predispose to dermatitis. Prevent small spills and leakage to avoid slip hazard.
